# Typical Inductance vs. Current Characteristics:





## **Typical Temperature Rise vs. Current Characteristics:**







## **Typical Impedance Characteristics:**




Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.
