


## Relative Spectral Sensitivity <sup>2), 3)</sup>

 $S_{rel} = f(\lambda)$ 




### **Directional Characteristics** <sup>2), 3)</sup>



### **Dimensional Drawing**<sup>4)</sup>






#### Recommended Solder Pad<sup>4)</sup>







Component Location on Pad






Handling Indication: The package is casted with silicone. Mechanical stress at the silicone surface of the unit should be avoided. Pickup the device at the plastic frame.








#### Tape and Reel <sup>5)</sup>






#### **Barcode-Product-Label (BPL)**

Moisture-sensitive product is packed in a dry bag containing desiccant and a humidity card according JEDEC-STD-033.



#### **Notes**
